2025 Fee Structure

Academy of Sound Engineering has various payment options available to our students for their 2025 studies. There are early settlement discount structures that will save up to R5,000 on 2025 studies.

Prospective applicants will be charged a once-off non-refundable Application Processing Fee of R500. This is an administrative fee and does not form part of the tuition fees.

Payment Option 5 – Monthly debit order

This is designed to be an affordable payment option with no added interest. The account payer and student must complete a debit order contract from Academy of Sound Engineering, which must then be approved by Academy of Sound Engineering.

New and existing students on the debit order system will pay a monthly fee of R7,995 over 10 months for Higher Certificate and Diploma programs, or R7,268 over 11 months.
